

## **Liability Waiver, Photography/videography Permission, and Transportation Permission**

**Liability Waiver:** I have requested Youth Helpers to allow my child(ren) to participate in any and all activities that may include but are not limited to those outlined in the camp brochure. As a condition of receiving this benefit, I do hereby agree to the following: I understand that my child(ren)'s participation in these activities can expose him/her to dangers both from known and unanticipated risks. Acknowledging that such risks exist, I on behalf of myself, my child(ren) and any other party who may have the right to assert any rights for or on behalf of my child(ren), do assume such risks, and do hereby forever release and discharge, indemnify, and hold harmless Youth Helpers Inc., Laurel Pines, its affiliates, officers, directors, agents, employees, insurers, successors in interest, attorneys, or any other person or persons associated with any or all of them who might be liable (the "Released Parties") from and against any and all claims, causes of action, actions, suits, demands, losses, damages, expenses, costs or liability (collectively, "Losses") arising from or in connection with my child(ren)'s participation in Youth Helpers camp and its activities, including, but not limited to, losses arising from the negligence of any of the Released Parties, whether such losses arise in connection with bodily injury (including death), property damage or otherwise (collectively, the "Released Claims"). The Released Claims include losses arising out of any condition of the premises at which the camp activities are held or the conduct of any person in connection with the preparation for, supervision of, or conduct of any activity, whether planned or unplanned. In the event that child(ren) abuse is reported while your child(ren) is at Youth Helpers camp, Released Parties may fully cooperate with Child Protective Services and Law Enforcement for the best interest of the child.

I, on behalf of myself, my child(ren) and any other party who may have the right to assert any rights for or on behalf of my child(ren) hereby waives all rights which I now or may have by virtue of Section 1542 of the California Civil Code which reads: "**A general release does not extend to the claims which a creditor does not know or suspect to exist in his favor at the time of executing the release, which, if known by him, must have materially affected his settlement with the debtor.**"

**Photography/videography Policy:** I give Youth Helpers Inc., Laurel Pines and all its affiliates permission to photograph and/or videotape my child(ren) and use his/her likeness in promotions, advertising social media, etc without compensation and hereby release and hold harmless Released Parties from and against any losses or liability connected therewith.

**Transportation:** I give Youth Helpers Inc., Laurel Pines and all its affiliates, permission for my child to ride a bus to and from camp coordinated through Youth Helpers Inc., Laurel Pines and all its affiliates and hereby release and hold harmless Released Parties from and against any losses or liability connected therewith.

**Health Insurance and Permission To Seek Emergency Medical Services for Child(ren):** I, on behalf of myself, my child(ren) and any other party who may have the right to assert any rights for or on behalf of my child(ren) hereby grant to Youth Helpers Inc., Laurel Pines, its affiliates, officers, directors, agents, employees to seek medical services for my child(ren), and to utilize the health insurance provided by me that pays the cost of such medical services. I also agree to reimburse Youth Helpers Inc. for any additional sums it pays for the medical services for my child(ren) during the time that my child(ren) are on the premises or involved in the activities conducted or not conducted by Youth Helpers Inc.

I further understand and acknowledge that I make this release in full accord and satisfaction of and in compromise of any and all Released Claims. I represent and acknowledge that I have read and understand this form and the release granted above and warrant that all statements made herein are true to the best of my knowledge. I have read and understand that by "signing" below I agree to the terms herein.
